Department of Political Science, Goalpara College, Goalpara having its registered office at Goalpara, Assam – 783101.


## Purpose & Objectives:

The purpose of this MoU is to create a framework for collaboration between SIPRD, Abhayapuri and Department of Political Science, Goalpara College, Goalpara with the objectives as given below:

- a) To establish close linkages and functional coordination between SIPRD, Abhayapuri and Department of Political Science, Goalpara College.
- b) SIPRD, Abhayapuri and Department of Political Science, Goalpara College will jointly organize Seminars and Workshops from time to time.
- c) SIPRD, Abhayapuri and Department of Political Science, Goalpara College will jointly undertake Research & Project works in emerging areas with local relevance by the students and faculty members of both the institutions.
- d) Both the Institutions shall jointly conduct faculty exchange programme for sharing knowledge and gaining experiences.
- e) Apart from the aforesaid linkage, both the Institutions shall collaborate to organize extension and outreach activities like field visit to Panchayat offices, Rural Development awareness programme and conducting community programmes.

This MoU is valid for a period of three years from the date of signing of the MoU and can be extended for a period of two years on the recommendation of a review committee. The MoU will automatically lapse after three years, unless renewed.
