HAVE REACHED the following understanding: -

ARTICLE 1

OBJECTIVE OF COOPERATION

ARTICLE 2

ARTICLE 5

FINANCIAL ARRANGEMENT

- 1. Any cooperation under this MoU is subject to the availability of funding sources and approval by relevant authorities.
- 2. Any specific project of joint interest will be detailed in a separate agreement, including financial and programme-specific arrangements.

ARTICLE 6

INTELLECTUAL PROPERTY RIGHTS

In the event that either Party wishes to disclose any data and/or information supplied in or resulted from the implementation of this MoU, the disclosing Party shall have prior written consent of the other Party.

ARTICLE 8

LIMITATION OF PERSONAL ACTIVITIES

The Parties shall ensure that their personnel engaged in the activities under this MoU shall engage only in activities under the framework of this MoU with respect to laws and regulations in the state of Assam and the country of India.
